Overwhelming response leads to a 4th Seminar

Is your building practical and sustainable?

In recent years, incidents related to the aging, maintenance, safety, quality and environmental issues of buildings have raised awareness of the need for practical and sustainable buildings.

In view of this, **Hong Kong Quality Assurance Agency (HKQAA), a non-profit-distributing organisation established by the Hong Kong Government**, launched the HKQAA SBI in November 2011. HKQAA SBI provides a simple and inexpensive building assessment scheme to facilitate buildings to measure and benchmark their sustainability performance against the norm performance of the buildings in Hong Kong as a whole. Designed with a balance of economic, social and environmental considerations, the scheme helps drive **long-term improvement in property management thus enhancing the quality and value of buildings.**

HKQAA launched the pilot scheme in the first quarter of 2012 with **subsidy on HKQAA SBI subscription and continuing professional development granted by the Hong Kong Government via the Sustainable Development Fund (SDF).**
