HKQAA 4th Wine Storage Management Systems Certificate Presentation Ceremony

HKTDC designates certified companies zone on Wine Fair

(9 November 2012, Hong Kong) The Hong Kong Quality Assurance Agency (HKQAA) held the 4th certificate presentation ceremony for the Wine Storage Management Systems (WSMS) Certification Scheme today on the HKTDC Hong Kong International Wine & Spirits Fair, as well as celebrating the Scheme in its 3rd Anniversary.

Taking systematic measures to protect wine quality and its value

Since the Hong Kong Government abolished the import duty on wine in 2008, the development of Hong Kong as a regional wine trading and distribution hub has gathered further momentum.

In support of wine-related businesses in Hong Kong and to enhance the city's reputation as an international wine hub, HKQAA partnered with the industry and launched the Wine Storage Management Systems Certification Scheme in late-2009, which has been enthusiastically supported by the industry. Its high-quality and unified wine storage standard allows the industry to take systematic and effective actions in **protecting wine quality and its value** during storage, thus enhancing the confidence of consumers and wine collectors.

In view of the growing demand from the industry, **WSMS – for Wine Retailers** and **WSMS – Transportation** certification schemes were released in January and October of 2011 respectively, extending the certification scope across the wine supply chain and across boundaries.

Zone designated for Scheme on Wine & Spirits Fair

To recognise the hard-earned accomplishment of the successful applicants, HKQAA held today the 4th WSMS Certificate Presentation Ceremony on the Hong Kong International Wine and Spirits Fair, as well as celebrating the Certification Scheme in its 3rd Anniversary. **Mr David Wong, Deputy Secretary for Commerce and Economic Development (Commerce and Industry) of the HKSAR Government**, was invited to present the certificates to the certified companies, including wine storage facilities and logistics companies.

"The Certification Scheme has been enthusiastically supported by the government, the Hong Kong Trade Development Council and the wine industry. Today, when visitors and customers see the certification marks, they know that the certified wine storage facilities are capable of a high standard of care. We are proud that the Scheme has received positive feedback and recognition from the industry," said Dr Michael P. H. Lam, Chief Executive Officer of HKQAA.

When organising this year's Hong Kong International Wine and Spirits Fair, the Hong Kong Trade Development Council designated an exhibition area especially for the Scheme's



certified companies, so that the visitors can instantly identify the wine storage facilities that have reached the certification standard.

"Since its inception, the Scheme has achieved great success in Hong Kong. I am very impressed to see the number of certificates issued has increased by 29 per cent this year. On behalf of HKQAA, I would like to offer my warmest congratulations to all the certified companies," said Ir Prof. Peter K. W. Mok, Chairman of HKQAA.

After the ceremony, a seminar was held and prestigious wine professionals were invited to share their knowledge and experiences in wine storage management.
