

Terms and Conditions

Registration

- a) Seats will be offered on a first-come-first-served basis. For details, please contact us at (852) 2202 9111.
- b) Registrants/participants are liable to settle the entire course fee once the enrolment form has been submitted.
- c) Confirmation of class schedule will be sent two months before class starts. If you do not receive any confirmation two months prior to the course, please call (852) 2202 9111.
- d) Payment should be made together with the enrolment form before the course commencement.
- e) Official receipt will only be issued upon written request.

Cancellation and/ or Changes

- a) Course fee is non-refundable or non-transferable to other courses unless a formal written request of withdrawal is received by HKQAA at least two months before the class commencement. Late enrollments are subject to the same cancellation deadline.
- b) Should a delegate fails to attend or withdraw after cancellation deadline, the full course fee remains payable.
- c) HKQAA reserves the right in any circumstances to cancel the Course, for example because of an insufficient number of participants or for whatever reason. The announcements will make two months before the course commencement.

報名
