

Legal Impacts on Business and Employment contracts under The new Contracts (Rights of Third Parties) Ordinance

The Contracts (Rights of Third Parties) Ordinance has taken effect from 1

January 2016 and applies to contracts (including commercial contracts, employment contracts, insurance policy, rental contracts, outsourcing and services agreements) entered into from this date.

Given the substantial legal implications of this Ordinance, it is important to update firm's contractual terms and standard agreement clauses so as to ensure that no unexpected third party claims would arise.

This seminar will introduce the key provisions of this Ordinance and explain how statutory third party rights might affect commercial agreements and employment contracts and all other types of agreements.
