HKQAA Website Privacy Policy

1. Introduction

This Privacy Policy (together with our terms and conditions and any other documents referred to in it) describes the type of information that the Hong Kong Quality Assurance Agency (hereinafter referred as "HKQAA", "we" or "us"), whose registered office is at 19/F., K. Wah Centre, 191 Java Road, North Point, Hong Kong, collect from you ("you" or "your") through the use of our services ("Services", which means services as may be offered from time to time on this Website), or the use of our website ("Website"), how that information may be used or disclosed by us and the safeguards we use to protect it.

Our Website and Services may contain links to third party websites that are not covered by this Privacy Policy. We therefore ask you to review the privacy statements of other websites and applications to understand their information practices.

We have drafted this Privacy Policy to be as clear and concise as possible. Please read it carefully to understand our policies regarding your information and how we will treat it. By using or accessing our Website or the Services, you agree to the collection, use and disclosure of information in accordance with this Privacy Policy. This Privacy Policy may be changed from time to time and your continued use of the Website or the Services is deemed to be acceptance of such changes. Please check regularly for updates to this Privacy Policy. If you do not accept and do not agree with this Privacy Policy, you must stop using our Website immediately.

We understand that some of our users are from jurisdictions other than Hong Kong and may require us to provide additional information to you about our data processing activities. Please refer to the appendices to this Privacy Policy that applies to you. We acknowledge that laws in certain jurisdictions not expressly mentioned in this Privacy Policy may afford additional rights to you in respect of your personal data. We anticipate that the rights set out in this Policy also provide you with such protection in relation to your personal data.

2. What we may collect

2.1 Personal data, or personal information, (collectively referred as "**Personal Data**") means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).

- 2.2 We may collect, use, store and transfer different kinds of Personal Data about you which may include but not limited to the following:
 - personal data that identifies you as an individual, including but not limited to your first name, last name, email address, credit card information, and phone number;
 - technical data, which may include internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform and other technology on the devices you use to access this Website;
 - profile data, which may include your username and password, reservations made by you, your interests, preferences, feedback, and survey responses;
 - usage data, which may include information about how you use our Website and Services;
 - marketing and communications data, which may include your preferences in receiving marketing from us and our third parties and your communication preferences;
 - interaction data, which may include any information that you might provide to any discussion forums on the Website;
 - cookies data;
 - third parties information which we receive about you from other sources; and
 - analytics including third-party analytics services (such as Google Analytics) to evaluate
 your use of the Website, compile reports on activity, collect demographic data, analyse
 performance metrics, and collect and evaluate other information relating to our
 Website and internet usage.
- 2.3 We also collect, use, and share aggregated data such as statistical or demographic data for any purpose. Aggregated data may be derived from your Personal Data but is not considered personal data in law as this data does not directly or indirectly reveal your identity. For example, we may aggregate your usage data to calculate the percentage of users accessing a specific website feature. However, if we combine or connect aggregated data with your Personal Data so that it can directly or indirectly identify you, we treat the combined data as Personal Data which will be used in accordance with this Privacy Policy.
- 2.4 We do not collect any sensitive Personal Data about you (this includes details about your race or ethnicity, religious or philosophical beliefs, political opinions, trade union membership, information about your health and genetic and biometric data). Nor do we collect any information about criminal convictions and offences.

3. How we may collect and use your data

- 3.1 We will take reasonable steps to ensure that your Personal Data is processed and used lawfully, fairly, and transparently, without adversely affecting your rights. We will only process your Personal Data if at least one of the following basis applies:
 - 1. you have given consent to the processing of your Personal Data for one or more specific purposes;
 - 2. processing is necessary for the performance of a contract to which you are a party or in order to take steps at the request of you prior to entering into a contract;
 - 3. processing is necessary for compliance with a contractual or legal obligation to which we are subject;
 - 4. processing is necessary for system administration and to report aggregate information to our advertisers;
 - 5. processing is necessary to protect the vital interests of you or of another natural person;
 - 6. processing is necessary for the performance of a task carried out in the public interest; and/or
 - 7. processing is necessary for the purposes of the legitimate interests pursued by us or by a third party such as our financial payments, except where such interests are overridden by the fundamental rights and freedoms of the data subject, in particular where the data subject is a child.
- 3.2 If we receive Personal Data in the course of providing our Services to you from another data subject, we expect you to have complete responsibility for ensuring that the contents of this Privacy Policy are brought to their attention and you have obtained their consent in the process.

We (or third party data processors, agents and sub-contractors acting on our behalf) may collect, store and use your Personal Data by way of different methods to collect data from and about you including through direct interactions with us. You may give us your information by filling in forms via our Website or by corresponding with us by post, phone, email or otherwise. This includes Personal Data you provide when you:

- 1. visit our Website;
- 2. use any of our Services;
- 3. create an account on our Website;
- 4. subscribe to our Services or publications;
- 5. request marketing information to be sent to you;
- 6. enter a competition, promotion, or survey; or

- 7. provide us with some feedback.
- 3.3 In addition to the above, we may use the information in the following ways:
 - 1. to ensure that content from our Website is presented effectively to you;
 - 2. to carry out Services relating to your membership;
 - 3. to personalise your user experience and to allow us to deliver the type of content and product offerings in which you are most interested;
 - 4. to administer a contest, promotion, survey or other such activities. Some of these activities have additional rules, which could contain additional information about how we use and disclose your personal information;
 - 5. provide information, and services that you request, or (with your consent) which we think may interest you;
 - 6. prevent or detect any misuse or fraud;
 - 7. if you have opted-in to receive our marketing information (e.g. periodic newsletters), we may contact you via e-mails, SMS, telephone or any other electronic means for marketing, advertising, and opinion research purposes.

In order to be able to contact you with information which may be of interest to you, your overall interaction us will be combined, analysed and used. We may use your Personal Data for marketing, advertising, and opinion research purposes. The period of use of the Personal Data will not be longer than we deem necessary but may be unlimited. If you would no longer like to receive such marketing information from us, please refer to the section below. If you have not opted-in to receive e-mail newsletters, you will not receive these e-mails. Users who register or participate in other website features such as marketing programs and 'members-only' content will be given a choice whether they would like to be on our e-mail list and receive e-mail communications from us.

3.4 We may keep a record of browsing activity and purchase history which are used the most to enable us to provide the most helpful information but we agree to keep such information confidential and you will not be identified from this information.

In addition, if you don't want us to use your Personal Data for any of the other reasons set out in this section 3, you can let us know at any time by contacting us at hkqaa@hkqaa.org, and we will delete your data from our systems. However, you acknowledge this will limit our ability to provide the best possible products and services to you.

3.5 You have the right to withdraw consent to our direct marketing communication at any time by contacting us at unsubscribe@hkqaa.org and we will either delete your data from our systems or move your data to our "unsubscribe list". However, you acknowledge this will limit our ability to provide the best possible services to you.

3.6 As already indicated above, with your permission and/or where permitted by law, we may also use your Personal Data for marketing purposes which may lead to us contacting you by email and/or telephone with information, news and offers on our Services. We agree that we will not do anything that we have not agreed to under this Privacy Policy, and we will not send you any unsolicited marketing or spam. We will take all reasonable steps to ensure that we fully protect your rights and comply with our obligations under the applicable data processing law.

4. Cookies

We use cookies to distinguish users and to improve our Website. Please read our Cookies Policy for more cookies information.

5. Where we store your data and security

- 5.1 To provide Services to you, we may transfer your collected Personal Data to storage outside of the country where you live. The data protection and other laws of these countries may not be as comprehensive as those in your own country. If we do store or transfer Personal Data outside of the country where you live, we will take all reasonable steps to ensure that your Personal Data is treated safely and securely in compliance with the applicable laws. Your acceptance of this Privacy Policy shall be your consent permitting us to store or transfer Personal Data to our overseas facilities if it is necessary for us to do so.
- 5.2 Data security is of great importance to us. To protect your Personal Data, we have put in place suitable physical, electronic, and managerial measures to prevent unlawful or accidental destruction, accidental loss, unauthorized disclosure or access or other unlawful forms of processing. In addition, we limit access to your Personal Data to employees, agents, contractors and other third parties who have a business need to know. They will only process your Personal Data on our instructions and they are subject to a duty of confidentiality.
- 5.3 We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.
- 5.4 Due to the open nature of the internet, it is impossible to guarantee that any of your Personal Data stored and collected will be free from unauthorized access. Notwithstanding the security measures that we take, the transmission of data via the internet may not be completely secure and we advise you to take suitable precautions when transmitting to us data via the internet. We disclaim any liability for any theft, loss of, damage or unauthorized access of any data or communications. By using our Website, you acknowledge that you understand and agree to assume these risks.
- 5.5 If we give you a password upon registration on our Website, you are solely responsible for keeping this password confidential. Please do not share it with anyone.

5.6 We retain Personal Data based on the business needs and the applicable statutory requirements. We will not keep your Personal Data longer than it is necessary. We may however be required to retain Personal Data for a longer period of time to ensure we comply with the laws in the applicable jurisdiction. We will review our data retention obligations to ensure we are not retaining data for longer than we are legally obliged to.

6. Disclosing your information

- 6.1 We will not disclose your Personal Data to any third parties aside from what is stated in this Privacy Policy without your prior consent. We may share your Personal Data with our legally affiliated entities. We may also disclose it if we have a legal obligation to do so, or in good faith believe that such action is necessary in order to protect other people's property, safety or rights. We may also exchange information with others to protect against fraud or credit risks.
- 6.2 We may contract with third parties to supply services to you on our behalf. These may include service providers of payment processing, search engine facilities, advertising and marketing; any personnel, agent, adviser, auditor, contractor, or service provider who provide services and advice to us in connection with our operation; and business partners of the events that you have registered. In some cases, the third parties may require access to some or all of your Personal Data. Such third parties will be obliged to treat such information in the strictest confidence.
- 6.3 Where any of your Personal Data is required for such a purpose, we will take all reasonable steps to ensure that your Personal Data will be handled safely, securely, and in accordance with your rights, our obligations, and the obligations of the third party under the applicable.

7. Your rights

7.1 When you submit information via our Website, you may be given options to restrict our use of your Personal Data. We aim to give you strong controls on our use of your Personal Data (including the ability to opt-out of receiving emails from us which you may do so by unsubscribing using the links provided above in this Privacy Policy).

7.2 You have the right to:

- request access to, deletion or correction of, your Personal Data held by us at no cost to you;
- 2. request that your Personal Data be transferred to another person (data portability);
- 3. be informed of what data processing is taking place;
- 4. restrict processing;

- 5. to object to processing of your Personal Data; and
- 6. complain to a supervisory authority.

7.3 You also have rights with respect to automated decision-making and profiling as set out in section 10 below.

7.4 You have the right to ask us not to process your Personal Data for marketing purposes. We will inform you before collecting your Personal Data if we intend to use your Personal Data for such purposes or if we intend to disclose your Personal Data to any third party for such purposes. You may choose not to provide your consent to such processing by not checking certain boxes on the forms we use to collect your Personal Data. You can also exercise your right at any time by contacting us at hkqaa@hkqaa.org or at the postal address set out in this Privacy Policy.

7.5 To enforce any of the foregoing rights or if you have any other questions about our Website or this Privacy Policy, please contact us at hkqaa@hkqaa.org.

8. Links to other sites

Our Website may contain advertisements or links to third-party websites. The presence of these links on our Website does not constitute an approval, authorization or affiliation with the websites in question. If you click on these links or use the services of a third party, you will leave our Website and you must consult the privacy policy of the website in question before sharing your personal data.

Certain products and/or services are offered to you as part of our Services in collaboration with third parties and you may be required to provide Personal Data to them in order to register and access their products or services. The identity of these third parties will be indicated at the time of registration. If you choose to register, you will transmit your Personal Data to these third parties and their use of your personal data will be subject to their privacy policies.

We are not responsible for the use of your Personal Data by such third parties and we cannot guarantee that they have the same level of data protection policy as us.

9. Changes

We may change our Privacy Policy from time to time. Any changes we may make to our Privacy Policy in the future will be posted on this page and, where appropriate and feasible, may be notified to you by e-mail. Your continued use of our Website or Services will be deemed as acceptable of the changes to the Privacy Policy.

10. Automated Decision-Making and Profiling

10.1 In the event that we use Personal Data for the purpose of automated decision-making and those decisions have a legal (or similarly significant effect) on you, you have the right to challenge to such decisions under the applicable, requesting human intervention, expressing their own point of view, and obtaining an explanation of the decision from us.

10.2 The rights described in section 10.1 does not apply in the following circumstances:

- the decision is necessary for the entry into, or performance of, a contract between you and us;
- the decision is authorised by law; or
- you have given your explicit consent.

10.3 Where we use your Personal Data for profiling purposes, the following shall apply:

- Clear information explaining the profiling will be provided, including its significance and the likely consequences;
- Appropriate mathematical or statistical procedures will be used;
- Technical and organisational measures necessary to minimise the risk of errors and to enable such errors to be easily corrected shall be implemented; and
- All Personal Data processed for profiling purposes shall be secured in order to prevent discriminatory effects arising out of profiling.

11. Terms and Conditions

12. Your Consent

By your continued use of our Website or our Services, you are deemed to have acknowledged and accepted our Privacy Policy.

13. Severance

If any part or provision of this Privacy Policy is prohibited or deemed to be void or unenforceable, that part or provision shall be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions hereof.

14. Dispute Resolution

14.1 All parties will use their best efforts to negotiate in good faith and settle any dispute that may arise out of or relate to this Privacy Policy or any breach of it.

14.2 If any such dispute cannot be settled amicably through ordinary negotiations between the parties, or either or both is or are unwilling to engage in this process, either party may propose to the other in writing that structured negotiations be entered into with the assistance of a fully accredited mediator before resorting to litigation.

14.3 All negotiations connected with the relevant dispute(s) will be conducted in confidence and without prejudice to the rights of the parties in any further proceedings.

14.4 If the parties agree on a resolution of the dispute at mediation, the agreement shall be reduced to writing and, once signed by the duly authorised representatives of both parties, shall be final and binding on them.

14.5 Any dispute shall not affect the parties' ongoing obligations under this Privacy Policy.

15. Governing Law

This Policy shall be governed by, and construed in accordance with, the laws of Hong Kong Special Administrative Region ("Hong Kong"). Any dispute, controversy, difference or claim arising out of or relating to these Terms and Conditions, including the existence, validity, interpretation, performance, breach or termination thereof or any dispute regarding non-contractual obligations arising out of or relating to it shall be referred to and finally resolved by arbitration administered by the Hong Kong International Arbitration Centre (HKIAC) under the HKIAC Administered Arbitration Rules in force when the Notice of Arbitration is submitted. The seat of arbitration shall be Hong Kong. The number of arbitrators shall be one. The arbitration proceedings shall be conducted in English.

Appendix

1. Privacy rights of users in European Economic Area

This section applies if you are based in the European Economic Area during your interactions with us.

We comply with the rights given to EU citizens under the General Data Protection Regulation (GDPR). Those rights are as follows:

- Correcting Your Information the right to have Your personal information updated to ensure it is up-to-date and accurate;
- Withdrawing Consent the right to withdraw Your consent to any processing that is currently being done under Your consent, e.g. marketing;
- Obtaining a copy of Your Information the right to receive a copy of the personal information We hold about You;
- Deleting Your information the right to request that We delete personal information in certain circumstances.
- Data Portability the right to have Us transfer to another controller the personal information that You have provided us with.
- Restricting Processing the right to request a restriction on the processing of Your data in some limited circumstances.
- Right to object to processing the right to request that We stop processing Your data for marketing purposes and in other limited circumstances such as asking Us not to process your data by wholly automated means or not to analyse Your information for targeted content etc. (also known as profiling).

Your personal data may be transferred and/or stored outside the EEA, including to countries which may have a lower level of data protection than under the GDPR. We shall comply with specific rules when We transfer personal information from inside the EEA to outside the EEA. We will use appropriate safeguards as permitted by the GDPR to protect Your personal data.

2. US - California Privacy Rights

For California residents, the CCPA also requires that businesses provide a specific right to opt out of the sale of personal information. We do not sell personal information that directly identifies You. However, the CCPA's broad definition of "sale" and "personal information" may deem the common flow of information in the digital analytics and advertising ecosystem to be a sale. 3. Mainland China

This section applies (in addition to the general Privacy Policy) to the processing of personal information of data subjects staying within the mainland People's Republic of China. Individuals located in Mainland China may have certain rights relating to their Personal Information that is not otherwise unavailable in other regions or countries. HKQAA respects each data subject rights and shall at all times protect your Personal Information in accordance with the applicable laws.

<u>Personal Information</u>. In this Section, Personal Information means any type of information (recorded via electronic means or otherwise) associated with an identified or identifiable natural person, but excluding information after anonymisation handling. Personal Information may include Sensitive Personal Information (defined below).

<u>Consent.</u> We will collect, store, use, process, transmit, provide, disclose or delete your Personal Information in accordance with this Privacy Policy and the applicable sections. If the applicable Mainland data protection laws and regulations require us to obtain separate consent, we will only process your Personal Information upon obtaining the requisite consent.

<u>Sensitive Personal Information.</u> We will collect and handle sensitive Personal Information, for example your credit or debit card information, account information for the processing of your payment. Your visit and activities on our Website, collected through cookies or other tracking technologies. It is necessary for you to provide us with such Sensitive Personal Information for the purpose of providing Services to you. If you do not provide us with your consent, your user experience and use of our Website may be limited.

Storing your Personal Information. Your Personal Information shall be stored in Hong Kong as well as in other regions or countries. If applicable Mainland Chinese laws require us to provide you with further notice and obtain your separate consent for the cross-border transfer, we will further provide such notice and obtain your separate consent.

Cookies Policy

Our Website uses cookies to distinguish you from other users on our Website. This helps us to provide you with a better experience when you browse our Website and also allows us to improve our Website. 2. 我們可能收集的內容

- **2.1** 個人資料或個人信息(統稱為「**個人數據**」),指可識別的自然人有關的各種信息,不包括身份已被刪除的數據(匿名數據)。
- 2.2 我們可能會收集、使用、儲存和傳輸有關您的不同種類的個人數據,這些數據可能包括但 不限於以下數據:
 - 個人身份識別數據,包括但不限於您的姓氏、名字、電子郵件地址、信用卡信息和電話號碼;
 - 技術數據,可能包括您用於訪問本網站的設備上的互聯網協議(IP)地址、您的登錄 數據、瀏覽器類型和版本、時區設置和位置、瀏覽器插件類型和版本、操作系統和平 台等技術;

- 配置文件數據,可能包括您的用戶名和密碼、您的預訂信息、您的興趣、偏好、反饋 意見和調查結果;
- 使用數據,可能包括您如何使用我們的網站和服務的信息;
- 營銷和傳播數據,可能包括您在接收我們和第三方營銷方面的偏好,以及您的傳播偏好。
- 交互數據,可能包括您向本網站任何論壇提供的任何信息;
- cookies 數據;
- 我們從其他來源獲得的關於您的第三方信息;以及
- 分析,包括第三方分析服務(如 Google Analytics),以評估您使用本網站的情況,編寫活動報告,收集人口統計數據,分析性能指標,並收集和評估有關我們網站和互聯網使用的其他信息。
- 2.3 我們還為任何目的收集、使用和分享匯總數據,例如統計數據或人口統計數據。匯總數據可能來源於您的個人數據但該數據在法律上不被視為個人數據,因為該數據不會直接或間接透露您的身份。例如,我們可能會匯總您的使用數據,以計算用戶訪問特定網站功能的比例。但是,如果我們將匯總數據與您的個人數據合併或連接以致能夠直接或間接識別您的身份,我們會將該合併數據視為本隱私政策項下的個人數據。
- 2.4 我們不會收集關於您的敏感個人數據(包括有關您的種族或民族、宗教或哲學信仰、政治 觀點、工會會員、健康、基因和生物特徵數據的信息)。我們也不會收集任何關於刑事定罪和 犯罪的信息。

3. 我們如何收集和使用您的數據

- 3.1 我們將採取合理的步驟,以確保對您個人數據的處理和使用是合法、公平和透明的,不會對您的權利產生不利影響。我們只會在以下任一情況下處理您的個人數據:
 - 1. 您已同意為一個或多個特定用途而處理您的個人數據;

1. 歐洲經濟區用戶的隱私權

如果您在與我們互動期間居住在歐洲經濟區(European Economic Area),則適用此部分條款。
