

## HKQAA Corporate Certificate

#### **Objective**


HKQAA offers distinct Corporate Certificates to qualified certified clients. The HKQAA Corporate Certificate, issued free of charge to the head office of a group/holding company or organization in addition to the certificates of the applicable standard held by individual subsidiaries or divisions, provide unique corporate level identity to management excellence. Designed to be used for promotional and marketing purposes, the Corporate Certificate together with its respective mark and unique corporate certificate number, represent and demonstrate the group company or organization's commitment and achievement in management system certification.

#### Criteria for HKQAA Corporate Certificate Issuance

The HKQAA Corporate Certificate will be awarded to HKQAA certificate holders who meet the following criteria:

- All subsidiaries/divisions/operating units within an applicant group/holding company/organisation's core
  activities have been certified by HKQAA against a single common standard (i.e. ISO 9001, ISO 14001,
  OHSAS 18001, TL9000) and that all certificates are valid at the time of the award. The group/holding
  company or organisation must be holder of a minimum of 3 certificates of the applicable standard to be
  qualified.
- 2. Applicant has to declare its commitment to have all its future or subsidiaries/divisions/operating units certified to the applicable standard by HKQAA.
- 3. Applicant applying for ISO 14001 Corporate Certificate must have its subsidiaries/divisions/operating units' **non-core activities** covered by in-house green office management practices and be included in the scope of the Corporate Certificate.
- 4. Applicant has to appoint a Corporate Management Representative and agree to/accept the one manday annual Corporate Certificate maintenance process.
