

## HKQAA Symposium 2010 Held Successfully

The Hong Kong Quality Assurance Agency's annual flagship event, the HKQAA Symposium 2010, was held successfully in November and December.

The event was held in three locations: the Langham Place Hotel in Hong Kong on 26 November, Purple Mountain Hotel in Shanghai on 3 December and Jianguo Hotel 21 Guangzhou on December. The 1000 Symposium attracted nearly participants from governments, industry and commerce, and academia, as well as members of the public. The main theme of the Symposium this year was "Tackling Sustainability Challenges with a Fact-based Approach". The morning session, "Building Towards Sustainability", focused on the role of the construction sector in sustainability development and discussed sustainable buildings, building safety, carbon footprints, benchmarking of corporate social responsibility (CSR), sustainability reporting and managing sustainability risks.



The Hong Kong session attracted 800 attendees.

In the afternoon session, "Measuring CSR to Drive Sustainability", the focus was on CSR benchmarking and a CSR Advocate Mark Presentation Ceremony was held. The Shanghai and Guangzhou sessions were themed "Low Carbon Innovation in Corporations" and "Greening Our Surroundings" respectively.

Sustainable development is a common interest of the community that requires the cooperation of every person, every business and every government. This year, we had more than 20 keynote speakers from government departments and renowned organisations and corporations, including the Hong Kong Housing Department, Hong Kong Housing Society, Global Reporting Initiative, Chicago Climate Exchange, British Consulate-General Guangzhou, Hongkong and Shanghai Banking Corporation, the University of Hong Kong and MTR Corporation.
