## From the Editor 編者的話

The HKQAA reached the high point of the year in November 2011 with three important events. First, we held the third certificate presentation ceremony for our Wine Storage Management Systems (WSMS) Certification Scheme - the first such scheme in the region - on 4 November 2011, Representatives from all WSMS-certified companies were invited to the cocktail reception to celebrate the extension of the Scheme across the wine supply chain.

On 25 November 2011, we held our annual flagship event, the HKQAA Symposium, to discuss topics related to corporate social responsibility and sustainable development. We also announced the benchmarking results of the HKQAA-HSBC CSR Index 2011 and handed out the CSR Advocate Mark to new mark holders, who are from different industries and of different sizes, encouraging them to continue their implementation of corporate social responsibility in the coming year.

At the Symposium, we were also pleased to launch the HKQAA Sustainable Building Index (HKQAA SBI). Since buildings play an important role in the sustainable development of the community, HKQAA launched the HKQAA SBI to provide a user-friendly and inexpensive building assessment system that is applicable to all types of buildings in Hong Kong. We give an overview of this new initiative in this issue of VISION.

In the new year to come, VISION will continue to bring you news and trends in the local and international markets, as well as reports on HKQAA's latest initiatives. We wish you health and prosperity in the Year of the Dragon!

在2011年的11月,本局舉行了多項重要的盛事:本局推出的國際首個「葡萄酒儲存管 理體系認證」計劃,於11月4日舉行了第三屆證書頒授典禮,並邀請了歷年獲認證的公 司參與我們盛大的酒會,慶祝認證計劃擴大至葡萄酒的供應鏈。

而在11月25日,我們舉行了一年一度的旗艦活動——「香港品質保證局專題研討會」, 討論多個企業社會責任和可持續發展的議題;同日,我們亦公布了「HKQAA-HSBC企 業社會責任指數2011」,並頒發了「HKQAA-HSBC企業社會責任先導者標誌」予新一 屆的先導者企業,鼓勵各行各業、不同規模的機構,於來年繼續履行社會責任。

此外,本局更在研討會上隆重推出「香港品質保證局樓宇可持續發展指數」。樓宇在香 港社區的可持續發展中擔任重要的角色,而「指數」的推出,旨在為全港任何類型的樓 宇提供一個容易掌握且低成本的評核指標,今期《管略》便會為大家介紹這項嶄新的倡 議。

踏入2012年,《管略》將繼續努力為讀者搜羅本地及全球的市場趨勢,並報導本局的最 新動向。祝願大家龍年進步,身體健康!

There are some 64,000 buildings in Hong Kong, and approximately 41,000 of these are private buildings, with the number of old buildings increasing all the time. These buildings have quite varied sustainability performance. Some buildings follow international environmental standards that take both practicality and sustainability into account. However, some might have been constructed merely with regard to practical use (like residential or commercial use) but not sustainability factors. They may also suffer from a lack of long-term planning about maintenance and renovation (such as installing LED lighting and security facilities). In Hong Kong, there have recently been several accidents related to issues like the maintenance, safety and quality of buildings, and these have raised awareness of the need for sustainable buildings.

The UNEP SBCI (United Nations Environment Programme, Sustainable Buildings & Climate Initiative) has found that buildings account for up to 40% of the energy use in society with equivalent levels of greenhouse gas emissions, 30% of raw materials use and waste generation and 20% of water consumption. The building sector provides the context for our daily lives, social interactions and economic development. It involves a number of stakeholders, including residents, building managers, owners and industry professionals, and is therefore important for the sustainable development of the community. Inadequate building management can have a serious negative impact on the economy, society and environment.

In fact, Hong Kong people's awareness about sustainable development has been increasing due to world-wide publicity campaigns. However, not everyone knows how to make buildings sustainable by paying attention to their management, maintenance, safety and other factors.

### A user-friendly and inexpensive assessment system

HKQAA launched its new initiative, the HKQAA Sustainable Building Index (HKQAA SBI) at the HKQAA Symposium held on 25 November 2011. The Index provides a user-friendly and inexpensive building assessment system designed with a balance of economic, social and environmental considerations, and applicable to buildings of all ages and types in Hong Kong. It encourages building stakeholders to contribute to the sustainable development of society by means such as improving maintenance management, upgrading energy efficiency and combating climate change.

目前,全港約有64,000座樓宇,約41,000座為私人樓宇,而高樓齡的樓宇數目正在陸續增加中。這些樓宇的可持續發展表現差異頗大,有些在興建時會跟從國際的環保標準,實用性與可持續發展因素兼備。然而,亦有一些樓宇在興建的時候,只會考慮實際用途(如居住、商業用途),沒有顧及對計劃續發展的影響;亦欠缺進行維修、翻新的長遠計劃(例如轉用LED燈、改善保安設施等)。而去年香港多宗與樓宇相關的意外和報導,亦令越來越多人關注樓宇維修保養、安全及居住質素等問題。

聯合國環境署可持續建築促進會指出,建築物佔整個社會中40%的能源消耗和溫室氣體排放量、30%的天然資源使用量和廢物產量,以及20%的耗水量。而樓宇作為日常生活、社交活動和經濟發展的重要舞台,在社區中牽涉許多持份者,如居民、樓宇管理者、業權擁有者及業界專業人士等,對社區的可持續發展有莫大影響,如果處理不善的話,更會對經濟、社會和環境三方面帶來巨大衝擊。

事實上,隨着全球對可持續發展的認識日增,香港 人對可持續發展的關注已有所提高,但並非所有人 都了解如何維持樓宇的管理、保養及安全性等質 素,令建築物能夠達到可持續發展的目標。

### 簡單、成本低的評核方法

香港品質保證局最近制訂了「樓宇可持續發展指數」,並在2011年11月25日的「香港品質保證局專題研討會」上舉行啟動儀式。指數為全港不同樓齡和類型的建築物,提供一個平衡經濟、社會和環境三方面績效,簡單且成本低的樓宇評核方法,鼓勵樓宇持份者加強樓宇保養管理,提升節能效率和應對氣候變化等,以貢獻於社會的可持續發展。

Ir Prof. Peter K. W. Mok, Chairman of HKQAA, said at the HKQAA SBI launch ceremony, "Hong Kong is closely packed with skyscrapers, but the stakeholders are not very aware of the sustainability of buildings. With the HKQAA SBI, we wish to arouse their attention, which will be beneficial both to our city and to the Earth."

The HKQAA SBI was developed based on the UNEP-FI / SBCI's financial and sustainability metrics report. It provides a quantitative assessment model with a set of simple, useful metrics for assessing and rating the key sustainability performances relating to a building's condition and operation.

"Buildings age over decades or even a century," said Ir Dr W. K. Lo, Deputy Chairman of HKQAA. "Their sustainability performance can be raised by improving building maintenance and management, as well as incorporating elements like accessibility and energy saving. The HKQAA SBI provides us with a standard for reference in this regard."

### Territory-wide benchmarking research

In order to find out the norm performance of building sustainability in Hong Kong, HKQAA will conduct the HKQAA SBI Benchmarking Research by randomly collecting performance data from buildings across Hong Kong in accordance with the ages and types of buildings. The analysed results will form the objective SBI measurement benchmarks.

The HKQAA SBI consists of a number of selected building sustainability performance indicators, which includes:

該指數以聯合國環境署可持續建築促進會的財務及 可持續發展評核報告為基礎,透過一系列簡單、易 掌握的公式,讓樓宇持份者能對樓宇的現狀和運作 時的可持續發展表現,作出評核。

「一幢樓宇的壽命可以長達數十年,甚至過百年。」 本局副主席盧偉國博士工程師道:「我們可以透過 強化樓宇保養和管理,加入無障礙及節能等元素, 提升樓宇在可持續發展方面的表現,而『樓宇可持 續發展指數』正好為我們提供一個參考指標。」

### 提供全港性比對指標

香港品質保證局按樓宇的種類及樓齡,抽樣收集全港樓宇可持續發展表現的數據,作「樓宇可持續發展指標研究」之用,以分析全港樓宇的平均表現概況及提供客觀的指數計算指標。

「樓宇可持續發展指數」包含多個有關樓宇可持續 發展的表現指標,當中包括:

The HKQAA SBI assesses a building's performance on a number of selected building sustainability performance indicators. By comparing a particular building against the norm performance in Hong Kong, the building's SBI score can be calculated. Building's stakeholders can use it to identify ideas in need of continual improvement.

The development of the economic, social and environmental factors may not necessarily contradict each other and they can even be complementary. For example, a building with good maintenance management can ensure the safety of its residents, which in turn raises the asset value. Energy conservation and carbon reduction can help owners save on monthly expenses.

### Subsidies for 150 HKQAA SBI subscribers

In order to encourage buildings to check their current position against the norm and disclose their sustainability performance, HKQAA will start the Pilot Scheme in the first guarter of 2012 to subsidise 150 buildings for subscribing the HKQAA SBI. The project is funded by the Sustainable Development Fund (SDF) of the Hong Kong Government. It will also subsidise training for 200 representatives of building stakeholders. The training will equip them with knowledge about the assessment metrics of the HKQAA SBI. After the training, eligible professionals will be able to register as SBI verifiers.

The HKQAA SBI will complement the existing building assessment systems and other sustainability drivers to jointly contribute to the economic, social and environmental development of the community at large, creating a better residential and living environment for Hong Kong people. It could also be users' and tenants' reference for consideration when the Index is widely used across Hong Kong.

「樓宇可持續發展指數」會評核樓宇多個有關樓宇 可持續發展的表現指標,並與全港性的表現進行比 對,從而得出該樓宇的「可持續發展指數」。樓宇 持份者透過與全港性的指標作出比對,便可了解其 樓宇需要改善的地方,並逐年作出檢討,藉此推動 樓宇的可持續發展。

經濟、社會和環境三方面的同步發展,未必一定互 相抵觸,相反,很多時候是相輔相成的。舉例來 説, 樓宇保養和維修得宜, 可保障居民的安全、提 高樓宇價值;如果在節能減排方面表現理想的話, 更有助業戶節省每月開支。

### 津貼150座樓宇進行評核

為鼓勵樓宇自發與全港的平均表現比對,並對外公 布其可持續發展表現,香港品質保證局將於今年第 -季展開「可持續發展先行者計劃」,誘過香港特 區政府「可持續發展基金」資助,津貼150座樓宇 參加「樓宇可持續發展指數」。此外,亦會津貼 200位樓宇持份者代表參加「樓宇可持續發展指數 培訓班」,教導他們如何應用指數中的公式,對樓 宇的可持續發展表現作出評核。完成培訓後,合資 格的專業人士更可登記成為「樓宇可持續發展指數 驗證員 | 。

「樓宇可持續發展指數」可以補充現有樓宇評核方 法和其他推動可持續發展的倡議,攜手促進香港整 體在經濟、社會和環境三方面的發展,為市民帶來 更好的居住及生活環境。而當指數於全港普及後, 更可成為用家、租戶的參考指標。

# HKQAA Symposium 2011 Held Successfully 「香港品質保證局專題研討會2011」舉辦成功

The HKQAA's annual flagship event, the HKQAA Symposium 2011, was held successfully on 25 November 2011 in the Ballroom of the Langham Place Hotel, Mongkok. The Symposium attracted over 700 participants from governments, industry, commerce and academia, as well as members of the public.

The main theme of the Symposium this year was "Performing Your Social Responsibility to Recreate the World". The event opened with the launch ceremony for a new initiative, the HKQAA Sustainable Building Index (HKQAA SBI). Following that, the Symposium's morning session, "Sustainable Infrastructure in the Making", addressed the issues of the measurement of building sustainability in Hong Kong, sustainable built environments, the accessibility of a cultural district and social responsibility in public housing development.

The afternoon session, "Sustainable World in the Making", covered the latest developments in corporate social responsibility in China and businesses' reaction to public views, and shared good practice in corporate social responsibility. A CSR Advocate Mark Presentation Ceremony was also held.

# HKQAA-HSBC CSR Index 2011 2011年HKQAA-HSBC企業社會責任指數公布



The benchmarking results of the HKQAA-HSBC CSR Index 2011 were announced at the afternoon session of the 2011 HKQAA Symposium. A ceremony was also held to recognise holders of the CSR Advocate Mark, which is now in its third year.

The HKQAA-HSBC CSR Index comprises two indices, namely the Hong Kong CSR Advocate Index and the Hong Kong 100 CSR Index.

本局在「香港品質保證局專題研討會2011」的下午環節 中公布了「HKQAA-HSBC企業社會責任指數2011」, 並舉行第三屆「HKQAA-HSBC企業社會責任先導者標 誌頒發典禮」。

指數共分2項,分別是「企業社會責任先導者指數」及 「香港100(HK100)企業社會責任指數 |。

### Hong Kong CSR Advocate Index

In this Index, the participating organisations are assessed by HKQAA on their maturity in 40 recommended CSR practices based on the ISO 26000 Guidance for Social Responsibility (published on 1 November 2010), and are given a score from 1 to 5. Those receiving an average score of 3 or above receive an HKQAA-HSBC CSR Advocate Mark.

23 organisations participated in the Index this year. The average score was 4.62 out of 5, up for the second year running. This shows that most participating organisations have implemented mature in-house systems to manage CSRrelated issues.



### 企業社會責任先導者指數

「企業社會責任先導者指 數」以2010年11月1日落實的 ISO 26000《社會責任指南》 為基礎,訂出40項社會責任的 建議措施,本局會派出專人前 往參與機構進行評審,並以1 至5分來衡量機構在推行社會 責任體系上的成熟程度,平均 分達3分或以上的機構均獲發 「HKQAA-HSBC企業社會責任 先導者標誌」。

今年共有23家政府部門及知名 企業參加,它們的總平均分為 4.62(滿分為5分),連續兩年 輕微上升,顯示大部分參與機 構均正在實施履行企業社會責 任的體系。

### Carbon and Energy Management Advocate Sub-Index

This year, a "Carbon and Energy Management Advocate Sub-Index" has been added, with the aim of providing more specific and in-depth analysis of performance related to carbon and energy management. Participants scored an average of 4.29 out of 5 on this sub-index.

Most of the participating organisations demonstrated that they have well-established criteria for the effective operation and maintenance of energy usage, and that they have conducted energy reviews to measure

their energy use. Some of them are planning for Carbon assessments certification such as ISO 14001 Environmental Management Systems and ISO 50001 Energy Management Systems Certifications in order to further enhance their energy performance. However, the overall performance is less mature when compared with other indicators and the maturity level varies from organisation to organisation.


### 碳排放及能源管理先導者分類指數



### Hong Kong 100 CSR Index

The second index, the Hong Kong 100 CSR Index, measures transparency in the disclosure of CSR issues in 100 companies selected from 14 industrial sectors. A set of 16 CSR indicators, developed with reference to ISO 26000, is used to study and quantify the CSR disclosure of the sampled organisations. The Index analysis focuses on the companies' websites, policy documents, reports and other publicly available information. The Hong Kong 100 CSR Index for 2011 is 67 out of 100, which is 1 point higher than last year. A higher score means greater transparency. Significant improvement has been found in transparency involving the integration of CSR into organisational policy, which also has the highest score among the 16 indicators.

### 香港100(HK100) 企業社會責任指數

至於另一項指數——「香港 100 (HK100) 企業社會責任 指數」,則包含16項參考ISO 26000《社會責任指南》的指 標,從14個行業中選取100 家香港機構,根據其官方網 站、公司政策及報告等資料 中分析其在履行社會責任上 的透明度,得分愈高代表透 明度愈高。今年的整體指數 為67分(滿分為100分), 比去年微升1分,其中,「制 訂社會責任政策」的透明度 今年顯著上升。

# **Third Wine Storage Management Systems Certification Scheme: Certificate Presentation Ceremony 2011** 第三屆「葡萄酒儲存管理體系認證」證書頒授典禮



The HKQAA held the third certificate presentation ceremony for its Wine Storage Management Systems (WSMS) Certification Scheme – the first such scheme in the region - on 4 November 2011 at the Hong Kong International Wine & Spirits Fair held at the Hong Kong Convention & Exhibition Centre.

### Certification scope extends across boundaries

In support of the robust and growing wine-related business in Hong Kong, HKQAA launched WSMS - for Wine Retailers and WSMS - Transportation certification schemes this year to extend the certification scope of the WSMS across the wine supply chain and across boundaries.

"The Scheme, initially designed for wine warehouses and cellars, has recently been expanded to cover wine retailing and wine transportation services. It helps safeguard industry standards across the wine supply chain and further boosts overseas confidence in Hong Kong's expertise in wine storage. This, in turn will enhance the city's reputation as an international wine hub," said Dr Michael P. H. Lam, CEO of HKQAA on the ceremony.

WSMS - Transportation is the latest scheme. It is applicable to the certification of management systems for transportation service providers operating within and through Hong Kong, including freight carriers and forwarders. To prevent deterioration of wine quality during transportation, applicants should take action like imposing stringent controls on temperature and security throughout the journey. If part of the transportation process is outsourced to a third party, they need to ensure that all the outsourced processes are well defined and controlled.

### 認證計劃範圍跨越國界

為支持香港正在蓬勃發展的葡萄酒相關業務,本局今年 先後分別推出了零售商「葡萄酒儲存管理體系認證」和 運輸服務供應商「葡萄酒儲存管理體系認證」,將整個 計劃的範圍擴大至葡萄酒的供應鏈,甚至跨越國界。

「認證計劃推廣至零售及運輸層面,為整個葡萄酒供應 鏈建立全面的業界標準,將可增加外國對香港存酒專業 能力的信心,更有助建立香港葡萄酒貿易中心的品牌。」 本局總裁林寶興博士致辭道。

運輸服務供應商「葡萄酒儲存管理體系認證」是認證計 劃的最新成員,適用於運輸葡萄酒的管理體系,包括由 外地運往香港或於境內的運輸,對象包括運輸商、貨運 代理商等。為防止酒質在運輸過程中受損,申請者須符 合多項準則,如運輸期間的溫度及保安要求等;此外, 如申請者將部分運輸工序外判,必須確保所有外判的程

# EMSD Quality and Safety Day 2011 機電工程署『品質及安全目2011』

A safe and healthy workplace is essential for any organisation which wants to achieve the high productivity and quality necessary to compete in the market place. Therefore, the establishment of an Occupational Health and Safety Management System is not only important for ethical and regulatory reasons, but is also financially beneficial.

With the aim of promoting the culture of occupational health and safety, the Electrical and Mechanical Services Department organised the first EMSD Quality and Safety Day in 2010. This year's event was held on 27 October 2011 at the EMSD Headquarters Building. Mr P. C. Chan, Chief Operating Officer of HKQAA, shared his experience of quality management and occupational health and safety.

### **Publication of ISO 19011**

ISO published its new International Standard ISO 19011:2011 "Guidelines for auditing management systems" on 15 November 2011. This standard was developed by a joint working group comprising most of the ISO Technical and Project committees responsible for developing management system standards. ISO 19011 now provides guidance on first, second and third party auditing for any kind of management system. It replaces the 2002 version, which had focused specifically on quality and environmental auditing.

The publication of ISO 19011 forms part of a larger initiative by ISO to promote harmonisation of its various management system standards, and to make life easier for those organisations that choose to implement a single (integrated) system to address the requirements of more than one standard.

ISO 19011:2011 is also much richer in content than its predecessor, in part due to the fact that topics specifically related to third party (certification) auditing are now addressed in a specific requirements standard (ISO/IEC17021:2011) aimed at management system certification bodies. ISO 17021 was published in February 2011.

The other main differences between ISO 19011:2011 and the 2002 version are as follows:

- remote audit methods and the concept of risk have been introduced
- confidentiality has been added as a new principle of auditing
- Clauses 5, 6 and 7, relating to the planning of the audit programme, performing individual audits and guidance on personnel competence and evaluation, have been reorganised
- additional information has been included in a new Annex B. resulting in the removal of the "help boxes" from the text of the 2002 version
- the competence determination and evaluation process has been strengthened, and now includes other key personnel as well as auditors and audit team leaders
- illustrative examples of discipline-specific knowledge and skills have been included in a new Annex A
- additional guidelines are available at the following website: www.iso.org/19011auditing

### ISO/TC 176 meets in Beijing

Over 150 delegates from 70 countries met in Beijing, China, from 24-29 October 2011 for the 28th plenary meeting of ISO's Technical Committee 176 (Quality management and quality assurance). Highlights of the meeting included:

- Discussions on the future long-term strategy for ISO 9001 and the ISO 9000 family in general
- Revision of the Eight Quality Management Principles on which the ISO 9000 family is based
- A review of the supporting application guidance and official interpretations
- Ongoing development of the new ISO 10008 guidance standard on e-Commerce Business-to-consumer transactions
- Final discussions on the new ISO 10018 guidance standard on the "People aspects of Quality"
- Acceptance of a new work item to develop a standard (ISO 17582) for government elections ("Quality management systems for electoral bodies - Requirements")

### ISO 19011正式出版

國際標準化組織(ISO)已於2011年11月15日出版新 國際標準——《ISO 19011:2011管理體系審核指南》。 大部分ISO管理體系標準的技術和項目委員會,均有份 參與草擬這項新標準。相較於2002年的版本只適用於 質量及環境審核,新版本ISO 19011的內容適用於任何 管理體系的第一方、第二方及第三方審核指引。

ISO 19011的出版,亦配合ISO協調眾多管理體系標準 的倡議,對一些想達到多個標準但只實施一個(綜合) 體系的機構來說,省卻許多繁複的工作。

ISO 19011:2011的內容比舊版本豐富得多,其中一 個原因是有關第三方(認證)審核的詳情,現已輯 錄於專門針對認證機構的ISO/IEC 17021:2011標準。 ISO 17021已於2011年2月出版。

新版本與2002年版本的其他主要修訂:

- 加入了遙距審核的方法和風險的概念
- 審核原則新加「保密 | 一項
- 重新整理了第5、6、7條,有關審核計劃、進行個 別審核和審核人員能力及評估的條款
- 刪去了2002年版中的「輔助資訊欄」,改為將附 加資料輯錄於新增的「附件B」中
- 增補了審核人員能力的評估和評估的過程;審核員 和審核組組長,以及其他相關的重要人員也包括在
- 新增「附件A」,根據審核對象的類型,提供相關 的資訊和審核技巧的實例

### ISO/TC 176 技術委員會北京會議

國際標準化組織TC176(質量管理及質量保證技術委員 會)於2011年10月24日至29日期間,在中國北京舉行 了第28次全體會議,共有超過150位來自70個國家的代 表出席。會議議題包括:

- 討論ISO 9001和ISO 9000系列大致上在未來的長
- 修訂ISO 9000系列所依據的「八項品質管理原則」
- 覆核ISO 9001的申請輔助指引和官方的釋義
- 繼續草擬新的ISO 10008《商戶對消費者電子商貿
- 有關「質量管理的人為因素」之新標準一 ISO 10018踏入最終討論階段
- 通過展開有關政府選舉的新標準——ISO 17582 《選舉團體的質量管理體系要求》的草擬工作

# Process Approach Auditing (Part 3 of 3) 過程方法事核 (三之三)

An audit plan shows the time the auditors are going to audit the individual departments / units. The sequence of auditee departments / units should demonstrate the audit trail, which is either in the same direction as the process flow or in reverse.

An effective process approach audit plan normally starts with a review of the overall performance of the management system (management review, internal audit, customer complaints, attainment of quality objectives, legal compliance, etc). This allows the audit team to identify the strengths, weaknesses and key problems of the organisation. Following the overview, an audit team discussion is needed to share the information obtained, tell the team what samples are to be drawn and define the audit focus.

The audit plan for each member in the audit team is either directed at the forward trail or backward trail of the product realisation processes. Using a factory as an example, a single auditor auditing the Sales department, Purchasing department, Logistics and Delivery department in sequence is a forward trail. A backward trail would be an audit of the QC department, Production department and R&D department.

The audit plan should allow sufficient time for team discussion and follow up. Although repeated auditing of a department by different auditors should be minimised, the audit team can still go back and check to confirm audit findings.

To implement a process approach audit effectively and efficiently, auditors should bear in mind the following factors:

- 1. Pick related audit samples, e.g. the same order number for the customer orders, purchasing orders, stock records and delivery orders to link the activities together.
- 2. The audit samples should demonstrate the completeness of the processes.
- Sometimes the quality of records is more important than quantity.
- Think about and compare the audit evidence collected rather than copying everything from records onto the audit notes.
- 5. Don't wait until the audit team meeting to share the audit evidence and information. Phone the audit team member for follow up when necessary.
- When the auditee organisation has multiple sites, audit the satellite locations first and then headquarters. Don't forget the interfaces between headquarters and the satellite locations.
- The audit plan can be changed when necessary.
- Start with the results of the process.

In the next issue, I will introduce the auditor skills and competences required to implement process approach auditing.

審核計劃的使用在於指示審核員何時該到有關部門 進行審核。部門受審核的次序應能展示出一個審核 路徑,而這路徑應是順著或是逆著業務流程。

一個有效的基於流程的審核計劃應先從檢視管理體 系的整體表現開始(管理評審、內部審核、顧客投 訴、質量目標的表現和法律法規符合性等)。所收 集得的資訊可讓審核組識別出組織的優勢和弱點, 以及組織存在的主要問題。接著,審核組的內部會 議溝通是不可或缺的,透過分享審核資訊,指示抽 取什麼審核樣本和訂立審核焦點,審核組組長當可 確立總體的審核主線和各分支與主線的交匯點。

審核組內各成員的審核計劃應是順著或是逆著產品 實現流程。以一間工廠為例,由一位審核員依序審 核銷售部、採購部、物流部和付運部展示出一個順 著產品實現流程的審核,而由另一位審核員依序審 核質檢部、生產部和產品設計開發部則是逆向審核 的例子。

審核計劃中還應安排充分的時間讓審核組進行會議 溝通和跟進。儘管需要減少由不同審核員重複審核 同一部門,但在需要跟進和確定審核發現是否存在 時,審核員仍需重回已被審核鍋的部門。

為進行有效和高效的過程方法審核,審核員應牢記 以下要點:

- 抽取關連的審核樣本,例如:相同或有關連號 碼的顧客訂單、採購單、倉存記錄和交付記 錄,從而將活動連在一起。
- 2. 樣本應能展示整體流程,從頭到尾。
- 應著重記錄的質量而不是數量。
- 4. 多思考和比較所收集的證據,而不是將記錄的 所有內容抄寫於筆記中。
- 有需要時,不要留待審核組會議才溝通,應立 即致電另一審核員幫忙跟進。
- 當受審核組織有多個外部分場所時,審核組最 好先安排對外部分場所的審核,然後再安排到 總部進行審核,這樣較有利於在受審核組織的 總部對其管理體系進行系統評價。審核時,不 要忽略過程的接口及外部分場所與總部的管理 接口。
- 審核計劃在需要時是可以更改的。
