

## Conversion Arrangement for HKQAA Hong Kong Registration – Cooking Oil 有關「香港品質保證局香港註冊 - 食油」轉版安排

The name of the former "Hong Kong Cooking Oil Registration Scheme" has been changed to "HKQAA Hong Kong Registration – Cooking Oil". The registration mark has also been revised. Please refer to Appendix 1 "Summary of Changes for HKQAA Hong Kong Registration – Cooking Oil". The changes of registration name and registration mark do not affect the validity of the current registration. A new certificate will be issued to the existing registered organizations after the completion of annual review.
