### Utilise Professional Knowledge to Foster Industry's Development 運用專業知識



After serving with us for many years, Ir Dr Hon. Lo Wai Kwok, SBS, MH, JP, will retire from his duties as Chairman of HKQAA in November 2019. Under his influential leadership and wise direction, HKQAA has become a leading conformity assessment body in Hong Kong and the region. He recently talked with VISION about how he joined the HKQAA Governing Council, and shared some thoughts about our future.

VISION (V): Dr Lo, you joined the HKQAA Governing Council many years ago and have been Chairman since 2013. What made you branch out to the field of ISO certification and become one of us?

Dr Lo (L): Total Quality Management (TQM) was promoted in the industry and commerce sectors and closely tied to the field of certification. In the 80s, when Europe promoted TQM, the Hong Kong Government kept up with the trend and established the Hong Kong Quality Assurance Agency in 1989 to promote quality management systems and introduce international standards in Hong Kong.

In 1988, I participated in a "Quality Hong Kong" event organised by the government, and went on a Hong Kong engineers' study tour trip to Beijing to learn more about the application on industrial engineering, which one of the topics was ISO 9001 Quality Management System. These experiences enhanced my knowledge of quality management.

In 1991, I led the company that I was working to obtain the first ISO 9001 Quality Management System Certification issued by the HKQAA, which encouraged me to join the Agency. Over the years, I have grown along with the Agency; first by joining the Governing Council, then by being elected as Deputy Chairman and now retiring as Chairman. It was an unforgettable and fruitful experience for me to be Chairman for 6 years.

### V: Which aspects of the progress made by HKQAA over the past 30 years have particularly impressed you?

L: The Agency keeps improving and innovating. The Agency promoted ISO 9001 Quality Management System, ISO 14001 Environmental Management System and OHSAS 18001 Occupational Health & Safety Management System in its early years. Later, it kept up with market trends by introducing diversified management

systems and brand-new services. HKQAA's Wine Storage Management System, for example, can be considered one of the most innovative certifications in the world.

管(管略): 盧議員加入董事局多年,於2013年 接任本局主席,貢獻良多。當年為何涉足ISO認證及 加入本局?

盧(盧議員):香港工商業界提倡全面品質管理 (TQM),與認證行業關係密切。80年代起,歐洲推 行品質管理系統,香港政府緊貼趨勢,在1989年 創立香港品質保證局,鋭意於香港推廣品質管理體 系,引入國際認證服務。

1988 年, 我參與了由政府舉辦的「Quality Hong Kong」推廣活動,以及以工業工程的應用為主題 的香港工程界北京考察團,其中一個課題是「ISO 9001 質量管理體系」,對於質量管理的認識亦因此 加深。

1991年,我帶領當時工作的公司成為第一家取得香 港品質保證局頒發的ISO 9001 質量管理體系證書的 機構,亦成為我加入本局的契機。由加入董事局成 為本局一員,及後擔任副主席,直到現在即將卸任 主席,多年來都與香港品質保證局一同成長。這六 年擔任主席的時間,為我帶來一段十分難忘及豐盛 的人生經歷。

### 管:本局三十年來有哪些工作成果令您印象特別深刻?

盧:本局不斷成長及創新,早期主要推廣ISO 9001 質量管理體系、ISO 14001環境管理體系及OHSAS 18001職業健康安全管理體系,之後配合市場發展, 引入更多元化的管理體系及創新服務,如本局獨創 的「葡萄酒儲存管理體系計劃」,為放諸全球也稱得 上創新的認證服務。







In recent years, the Agency has actively promoted social responsibility and sustainability. As green finance has become one of the hottest topics, the Agency has also developed the Green Finance Certification Scheme and received positive responses from the financial industry. This was a breakthrough for HKQAA.

Also, the Agency has expanded to Guangzhou, Macau, Shanghai and Xian. The depth, breadth, content and geographical reach of HKQAA's services have been enhanced during these years. We could not have accomplished this achievement without the leadership of the Governing Council and the great efforts of our staff members.

### V: How do the innovative services of the Agency contribute to industry?

L: The Agency has been exploring new opportunities in addition to the traditional certification, and developing schemes with vision. Recently, we launched the Green Finance Certification Scheme, Residential Care Home for the Elderly Certification Scheme, and the Strengthening Program for the Understanding and Implementation of the GB Quality Standard of Scrap Paper in Hong Kong Recycling Industry. The Agency's target groups have expanded beyond industrial and engineering and now include service, food and beverages, and property management. These services not only help industries to enhance their management performance in the market, but also boost their competitiveness. The impressive result of our brandnew services proves that certification services can be innovative.

**V:** You are successful in both your business and political careers, and have received numerous awards, such as "Ten Outstanding Young Persons", "Young Industrialist Awards of Hong Kong" and a Silver Bauhinia Star. You are also a Member of the National Committee of the Chinese People's Political Consultative Conference. Could you share with us your experience of success?

L: I was born and raised in Hong Kong, and am proud of being a professional engineer. I believe engineers should strike a balance between development and conservation. Therefore, I strive to utilise my professional knowledge and experience to serve society. I became a member of the Hong Kong Institute of Engineers and became the President in 2007, and was elected as the engineering representative in the Legislative Council in 2012. At the same time, I served

in public organisations such as the Housing Society, the Hospital Authority, the West Kowloon Cultural District and the Airport Authority. I appreciate the opportunity to give back to society and express my opinion as a representative of the engineering industry. I was also appointed by the Government to serve as a Member of Sha Tin District Council for over ten years. My work in the District Council was a challenging but also enriching experience for me in the society.

近年,本局著重宣揚社會責任及可持續發展概念, 隨著綠色金融成為國際熱門課題,本局亦在香港特 區政府大力支持下開發了綠色金融認證計劃,得到 金融財經界的廣泛響應,實為本局一大突破。

此外,本局早著先機開拓內地市場,業務地域擴到 廣州、澳門、上海以及西安等地,可見本局多年來 服務的深度、廣度、服務內容以及地域擴展都有傑 出成就。能夠取得這些成就,實有賴董事局的英明 領導以及各部門同事的努力付出。

### 管:您認為本局推出的創新服務對業界有何貢獻?

管: 盧議員在社會備受尊敬,先後獲得十大傑出青年、香港青年工業家、銀紫荊星章等榮譽,更獲選為全國政協委員,對社會建樹良多,可否分享一下成為社會傑出領袖的經驗和心得?

盧:我在香港土生土長,以專業工程師的身份為榮。我認為工程師的任務是要在發展及保育之間取得平衡,因此,我致力運用專業工程知識及經驗為社會服務,於80年代成為香港工程師學會會員,在2007年成為會長,後來在2012年獲選為工程界的立法會代表,同時為房屋委員會、醫院管理局、西九文化區及機場管理局等機構服務。我十分珍惜回

饋社會,以及代表工程界於社會上發表意見的機會。我亦曾獲政府委任, 有十多年在沙田區議會服務。區議員的工作充滿挑戰,也豐富了我的社會 歷練。

我認為傑出的領袖必須能夠帶領團隊並且要建立企業文化,本局三十年來在這兩方面成就出眾。在團隊建立上,董事局成員齊心做好機構







I believe outstanding leaders should be competent in team building and promoting corporate culture, as the Agency has done over the last 30 years. The core ingredient behind a successful company is teamwork. Our Governing Council members ensure good corporate governance, and the management team has successfully established a cross-regional team to create our competitive edge, the "4ls": "Integrity", "International Recognition", Innovation" and "Information". On the matter of corporate culture, we upholds the shared value of "GIFTS" - "Growth", "Integrity", "Fairness", "Team with Joy" and "Social Responsibility", where the letter "I" also stands for integrity. The Agency's certification services stress integrity, so we uphold integrity in our daily work. The Agency organises company-wide meetings periodically to enhance team spirit. Also, we contribute to society by sponsoring and encouraging staff members to participate in community service, so that the corporate culture can be well developed.

**V:** You have participated in a lot of public service. You are currently a Member of the Legislative Council, representing the Engineering Functional Constituency, as well as being HKQAA's Chairman. How do you achieve a work-life balance and contribute to society at the same time?

**L:** I am honored to serve society in various positions. Individuals have limited power. No-one in an engineering team can finish the work alone. I hope everyone can seek common ground while minimising differences and building up a better society together.

I lay emphasis on both my work and family. Music provides a healthy balance for my life. I learnt musical harmonica during my childhood, and then learnt other instruments such as flute, Erhu, Pipa, Qinqin, saxophone, Guzheng and Guqin. Nowadays, I belong to music groups that perform pop songs, Cantonese Opera and Chinese traditional music. I make use of these personal hobbies during work occasions, for example, performing at community events and functions of the industrial sector.

As you can see from my Facebook page, I cook with my family to enhance our cooking skills and so that we have a shared hobby.

### V: HKQAA marks its 30th Anniversary this year. Can you share your feelings with us?

L: HKQAA was established by the Hong Kong Government but has become financially independent very soon. Besides undertaking our basic functions, providing professional certification for various industries, HKQAA has also

utilised its resources to develop brand-new services and expanded its business scope. Looking back on the last 30 years, HKQAA can be called a successful organisation.

Hong Kong has had different strategic positions in different periods. The Greater Bay Area Development and Belt and Road Initiative have brought regional improvements, and fostered intercultural communication and racial harmony. In this ever-changing society, we need innovative ideas so

that we can seize opportunities and move forward.

**盧**:我十分有幸能夠在不同崗位為社會服務。個人力量終究有限,正如工程團隊的工作不能單打獨鬥一樣,我期望眾人能求同存異,同舟共濟,合力建設更美好的社會。

工作及家庭兩者也須花時間兼顧,音樂是我生活的調劑。童年時代我自學口琴,隨後學習笛子、二胡、琵琶、秦琴、色士風、古箏和古琴等樂器,現時參與流行曲、粵曲、中樂等等不同音樂的組合。雖說只是個人的興趣,但也可於工作上大派用場,在參與地區服務及業界活動時演出。

另外,正如我在Facebook專頁上所示一樣,我會與家人在家中自製「盧家私房菜」,磨練廚藝之餘,亦能培養家庭的共同興趣。

### 管:本局迎來三十周年誌慶,請分享你的感受?

■:作為香港政府成立的機構,本局運營不久後便自給自足,除了發揮基本功能,為業界提供專業認證服務外,本局積累了足夠資源發展,不斷開發創新服務及壯大業務規模。總結來說,香港品質保證局自創立三十年以來屢創佳績,可謂光輝三十年。

隨著時代進步,香港角色不斷轉型,大灣區建設及

一帶一路倡議,帶來了區域進步,促進文化文流與種族和諧, 意義重大。社會在不斷變化,展 望未來,我們需要創新思維,把 握得來不易的機遇,方能進一步 取得佳績。

The Forum featured acclaimed local and overseas speakers who discussed topics including fintech governance, sustainable construction, ESG related risks and green finance developments.

### **Foster Development in Construction and Fintech Industry**

During the forum, HKQAA announced to establish a strategic partnership with BRE Group Limited to drive positive change in the Hong Kong construction sector, starting with the promotion of international best practice, training and certification in Building Information Management modeling and green building. Also, HKQAA's collaborates with JETCO to facilitate the development of open banking ecosystem in accordance with Hong Kong Monetary

### 與業界合作 促進建築業及金融科技發展

為了推動香港建築業持續進步,本局與英國建築研究院集團 (BRE Group)簽署合作備忘錄,旨在推廣建築信息管理(BIM)模型的國際良好做法、培訓及認證,以助業界提升水平及競爭力,促進建築創新技術。

另外,為配合香港金融管理局的智慧銀行倡議,本局最近亦會與銀通香港合作促進開放銀行(open







#### Introduction

An ageing population presents an unavoidable social problem for most developed countries today. As an international metropolis, Hong Kong also faces this challenge. According to recent census statistics from the HKSAR Government, it is expected that the elderly population will reach 30% of the total population in 2036, stretching to their limits residential care services for the elderly. There has also been a lot of negative news about the poor service offered by residential care homes for the elderly (RCHE) in recent years.

HKQAA initiated the development of a certification scheme - "Residential Care Home for the Elderly Certification Scheme" (RCHE-CS). This new certification service was officially accredited through the Hong Kong Certification Body Accreditation Scheme (HKCAS) run by the Hong Kong Accreditation Service. The Scheme takes into consideration the views of different stakeholders and the Government's initiative to strengthen and assist RCHE to further enhance their service standards. It builds on the achievements of the "Service Quality Management Certification Scheme – Elderly Services" (SQM-ES). The purpose of the Scheme is to encourage local RCHE to optimise their management systems and enhance service quality, and to enable the public to obtain more objective information when selecting a RCHE. The Scheme emphasises the establishment of a management system that is practical for elderly services.

### **Scheme Structure and Content**

In order to develop this certification Scheme, HKQAA conducted extensive consultations with relevant stakeholders in society including the Social Welfare Department, private and subsidised organisations that operate RCHE, and professionals from the medical, healthcare and social welfare sectors. Industry representatives were invited to form a service management technical committee to provide professional advice on the certification programme. The Scheme covers the Residential Care Homes Ordinance, the Social Welfare Department's Code of Practice for the Elderly, and sixteen Service Quality Standards (SQS).

RCHE-CS has inherited the main features of SQM-ES, including the "Management System Audit", "Microbiological Test" and "Service Quality Interview" (see below). These procedures make use of objective and scientific methods to collect evidence, and conduct analysis and reviews of evidence. The new Scheme strengthens the practical monitoring part of the requirement to provide a set of comprehensive and objective indicators for assessment.

### Management System Audit

This is conducted on-site and based on risk considerations, sampling various aspects of the operation and management of RCHE. It aims to ensure that the RCHE has established an appropriate organisational structure and operational system with clear staff duties and adequate training. These enable effective operation and continuous monitoring and improvements in service quality. HKQAA arranges unannounced surveillance audits for RCHE to assess if the operation performance of the management system meets the requirements.

### Microbiological Test

HKQAA has appointed a Hong Kong Laboratory Accreditation Scheme (HOKLAS) accredited laboratory to conduct microbiological testing of food samples. This will provide objective evidence of the effectiveness of food provision and hygiene monitoring systems, and increase user confidence.

### 簡介

人口老化是今天大多數已發展國家須面對的社會問題。香港作為國際大都會,同樣正面對人口急劇老化所帶來的挑戰。根據香港特區政府近年的人口普查統計數字顯示,政府預計長者人口比例將於二零三六年達至總人口三成,從日益嚴峻的人口老化趨勢中可預計未來香港社會應付體弱長者對住宿照顧服務欠售的負面新聞,安老院舍質素參差的問題亦引起社會關注。市民在選擇安老院舍時,變得更為小心審慎。

為鼓勵本地安老院舍優化其管理體系及提高服務質素,並讓市民能於選擇時獲得更多客觀資訊,本局於早年推出了「安老服務管理認證計劃」(SQM-ES),為安老院舍提供自願參與的評審服務經過多年推行,取得了一定成效。

因應不同持分者的意見,並回應政府加強及協助安老院舍進一步提升服務水平的大方向,本局於去年初啟動了「安老院舍認證計劃」(RCHE-CS),以緊貼市場需要。此認證服務已取得香港認可處香港認證機構認可計劃(HKCAS)的認可資格。

### 計劃架構及內容

為制定本認證計劃,本局進行了廣泛諮詢,向社會各界相關持分者吸納意見,當中包括社會福利署、營運安老院舍的私營及津助機構,以及來自醫護及社福界的專業人士,並邀請業界代表組成服務管理技術委員會,為安老院舍認證計劃提供專業意見。本計劃過級一個人工的。 查考院條例、社會福利署的安老院實務守則、16服務質素標準(SQS)等業界標準作為認證標準,並繼承了SQM-ES的主要特點,包括「管理體系審核」、「微生物測試」及「服務質量意見訪查」,加強實務監控要求的部分,以提供一套全面和客觀的參考指標作評審之用。

本計劃強調建立一套能針對安老服務實際運作的管理體系。計劃採用客觀及科學方法收集證據,綜合從「管理體系審核」、「微生物測試」及「服務質量意見訪查」各部份所收集的證據進行分析和評審,從而作出認證結論。

「管理體系審核」以現場審核方式,基於風險考量以抽樣形式,就安老院舍運作及管理各方面進行評估,確保安老院舍已建立合宜的組織架構與運作制度,包括清晰訂明員工職責及提供所需培訓,能有效運作,並持續監察及提升服務質素。本局更會為院舍安排突擊監督審核,以了解管理體系的持續運作情況。

「微生物測試」是本計劃的另一特點,本局委托由香港實驗所認可計劃認可的實驗所為院舍的食物樣本進行微生物測試,為院舍在食物供應及衛生監控系統方面的執行成效提供更多客觀證據,有助加強服務使用者的信心。



### Service Quality Interview

Residential care is people-orientated. HKQAA attaches great importance to the views of the elderly, their families and staff in the elderly homes. HKQAA will interview these different stakeholders, thereby enhancing the transparency of the service.

### **Benefits**

The implementation of this Scheme will benefit elderly homes and their service users:

- Elderly homes can demonstrate their ability to establish a sound management system and enhance their service quality;
- Establish a monitoring system to foster continuous improvement;
- Understand strengths and weaknesses;
- Demonstrate the ability to provide elderly services to a consistent standard;
- Improve their image and so enhance their overall competitiveness;
- Service users can obtain more objective information when choosing an elderly home and have another channel to give their views on the quality of service

The Scheme will therefore make an important contribution to improving quality in the residential care homes sector.



# Food Safety in Food Allergen Course

Accurate food information is important as it ensures public food safety and minimises the risks and liability for the industry. The World Health Organization actively promotes healthy dietary habits to reduce the risk of conditions such as heart disease, high blood pressure and diabetes. The European Union promulgated a new law in 2011 which requires restaurants in specific areas to label foods which contain potential allergens to prevent food allergy incidents.

The course content is based on food allergen information provided by the Chartered Institute of Environmental Health, U.K., CIEH, the Centre for Food Safety in Hong Kong and neighbouring areas.

世界衞生組織致力提倡建立健康飲食的習慣,有助減低患病(如心臟病、高血壓或糖尿病等)風險,與此同時,歐盟亦在2011年頒佈新法例,規管相關地區食肆,要將所有含致敏原食材菜式標示出來,以避免發生食物敏感意外。可見健康及正確的飲食資訊非常重要,除了能保障公眾食物安全外,亦可減低業界風險及責任承擔。

# Coaching Leadership - Unleashing Potential 教練式領導 - 釋放員工潛能

Leadership is a main concern of supervisors and managers. Often, leadership means managing employees by giving them instructions. In contrast, coaching leadership motivates employees by self-realisation. A study has shown that coaching skills can bring financial returns of 6 times the cost, and can enhance team cooperation and morale. This course uses an interactive method to teach coaching skills. Participants can make use of these skills to assist their employees to achieve self-enhancement.
