However, a statement including identification (e.g. brand or name) of the certified client, type of management system and applicable standard, and the certification body issuing the certificate may be printed on the product packaging or in accompanying information. The statement cannot imply that the product, process or service is certified. Product packaging is considered as that which can be removed without the product disintegrating or being damaged.
