

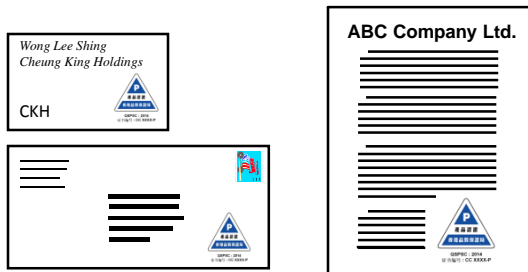

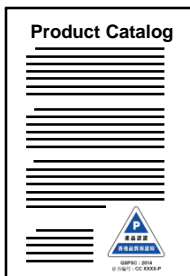

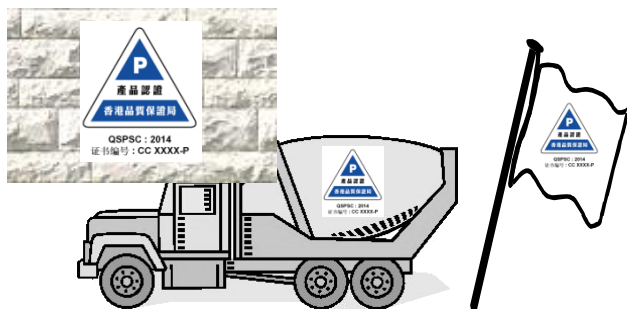

## Partial Certification 部分认证



The mark cannot be applied to a group of companies in which only some of them are certified.

标志不适用于超过一间公司而其中只有个别公司已获取认证。

e.g.: In the business card shown above, if only AB Ltd. is certified, the mark cannot be applied.

The mark cannot be applied to the corporate that only some subsidiaries are certified.

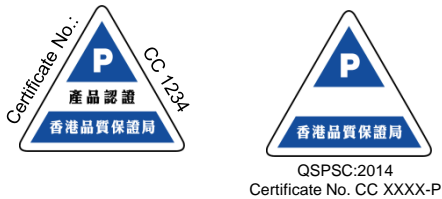
