

MoU signed with Guangdong-Hong Kong-Macau Greater Bay Area Standard Innovation Alliance and World WLAN Application Alliance

On 5 May 2023, HKQAA signed a Memorandum of Understanding (MoU) with Guangdong-Hong Kong-Macau Greater Bay Area Standard Innovation Alliance and World WLAN Application Alliance (WWA). The signing took place in Shenzhen at a Seminar on Shenzhen-Hong Kong Standard Interconnection Mechanism Innovation.

The parties will strengthen exchange and cooperation in the areas of standards development, talent cultivation, evaluation and certification, and establishment of the information service platform to facilitate the Shenzhen-Hong Kong standardisation cooperation mechanism.

Dr. Michael Lam, Chief Executive Officer of HKQAA, said that he looked forward to HKQAA joining hands with industry to facilitate green finance in the Greater Bay Area (GBA), following the Chinese Government's green development strategy. In doing so, a great contribution would be made to the sustainable development of the economy and the environment. Mr. P C Chan, Deputy CEO of HKQAA, met with experts in the field of standardisation and GBA industry representatives. They exchanged views on promoting standards interconnection between Shenzhen and Hong Kong.
