

Product, Product Label and Packaging 產品、產品標籤及包裝

The mark shall not be used on ultimate product, product label or packaging. However, a statement including identification (e.g. brand or name) of the certified organisation, type of management system and applicable standard, and the certification body issuing the certificate may be printed on the product packaging or in accompanying information. The statement cannot imply that the product, process or service is certified, and it is not permitted to use any statement on product packaging that an organisation has a certified food safety management system. Product packaging is considered as that which can be removed without the product disintegrating or being damaged. This includes all product packaging, both primary packaging (which contains the product) and any outer or secondary packaging.

Example of statement, "This product is manufactured by ABC Company under a HKQAA ISO 9001 / ISO 14001 certified quality / environmental management systems (specific standards)".
