Compliance Management

What is **Compliance** anyway ?

Compliance - meeting all the organization's compliance obligations

Compliance obligations - requirements that an organization mandatorily has to comply with as well as those that an organization voluntarily chooses to comply with

Requirement - need or expectation that is stated, generally implied or obligatory

Why Compliance Management is Important?

- Helps to manage risks
 - Changing product and service offerings
 - New legislation, regulation, interpretations, court decisions that address developments in the marketplace and are relevant to the product and service offerings of the organization
- Noncompliance may result in:
 - Litigation, monetary penalties, and other formal enforcement actions

Compliance Management

- Integrity and compliance are the basis for a successful and sustainable organization
- But compliance management is more than just compliance to laws and regulations
- Organizations are also required to deal with varying requirements from
 - Stakeholders (e.g. customers, community, etc.), industry codes
 - Organizational standards and benchmarks voluntarily chosen by the organization
 - Organizational policies and codes

Compliance Management System

- An effective compliance management system enables an organization to demonstrate its commitment to compliance with relevant laws, including legislative requirements, industry codes and organizational standards
- In jurisdictions, the courts may consider an organization's commitment to compliance through its compliance management system when determining the appropriate penalty –
- Due diligence

- Requirements with guidance for use
 - Published in April 2021
 - Replace ISO19600:2014
 - Becomes a certifiable standard complimented by guidance in Annex A

ISO 37301:2021 Compliance management systems

- Requirements with guidance for use
 - Some new elements from ISO 19600:2014 are
 - the inclusion of the employment process due diligence in hiring and promotion and disciplinary action in case of violation of compliance obligations
 - further strengthening of employee reporting and employee protection
 - > principles for investigation processes

ISO 37301:2021 Compliance management systems
 Requirements with guidance for use

- provides a framework to assist in the implementation of specific compliance-related requirements in any management system
- Defines requirements and provides guidance for establishing, developing, implementing, evaluating, maintaining and improving an effective compliance management system in organizations





ISO 37301:2021 Compliance management systems
 Requirements with guidance for use

 Applicable to all types of organizations regardless of the type, size and nature of the activity, public, private or non-profit sector





 Adopted the "high-level structure" (i.e. common clause sequence, common text and common terminology) developed by ISO to improve alignment among various and numerous management systems standards
