# Launch of the HKQAA CSR Platform - BFA 「香港品質保證局社會責任平台 — 無障礙」正式推出

HKQAA has always paid attention to the concerns of the disadvantaged members of our community. With this in mind, the HKQAA CSR Platform - BFA (Barrier Free Accessibility) Scheme was launched on 29 August 2013.

## Creation of job opportunities for people with disabilities and elderly people

This is the first project organised by the HKQAA CSR Platform and all types of enterprises and organisations are welcome to participate. Physically challenged, visually-impaired and hearing-impaired persons, as well as the elderly, will be trained and employed by HKQAA as mystery shoppers. They will use an objective standard to assess the BFA performance of different industries. HKQAA will analyse their assessments and share the results with public.

By implementing these meaningful and effective CSR projects, the participating organisations can raise BFA awareness among their employees. They can also enhance their performance and competitiveness, and improve their corporate image by showcasing their concern for society.

We believe this scheme is of great significance. It encourages various sectors

of the community to build a barrier-free society by creating more job opportunities for disabled and elderly people. These disadvantaged groups may therefore become more involved in society and, because they receive equal treatment as employees, this helps them gain the dignity they deserve as they bring their talent into full play. This will then generate more business opportunities. The result could be a situation

in which society, businesses and the disadvantaged benefit.

# About the HKQAA CSR Platform 「香港品質保證局社會責任平台 | 簡介

The HKQAA CSR Platform aims to provide an interactive platform for the commercial sector and disadvantaged members of the community, or the relevant public service organisations, to enhance their mutual understanding. It also integrates the capacity of the challenged people and the demands from industry and encourages them to be more involved in society through employment. In turn, this will enhance the brand image and competitiveness of organisations.

#### Enhanced cooperation between commercial and public service organisations

At present, there are few similar types of CSR platform in Hong Kong, and those that are operational may not have a set of mechanisms for enhancing the quality of CSR projects and service providers. HKQAA will manage the platform and will also play a role in knowledge transfer and quality assurance. We will help the commercial sector to organise CSR projects and public service organisations to strengthen their management capacity, assuring the standard of these projects and services.

Through this platform, the commercial sector can be matched withsuitable partners to carry out various CSR projects in addition to the BFA project. All participating organisations will be awarded a HKQAA CSR Companion Mark so as to showcase their commitment and contribution.
